Tenpin bowling Athlete Nomination Procedure for 2022 World Games

The following nomination criteria for the 2022 World Games is fully consistent with the established mission and values of the Canadian Tenpin Federation (CTF). The Internal Nomination Procedure have been developed with the objective of selecting a team/athlete that will represent Canada at Birmingham, Alabama for the 2022 World Games as members of Team Canada.

The objective of the nomination policy and procedures is to select the maximum number of medal potential athletes for the World Games Team.

The Internal Nomination Procedure (INP) has been developed with objective of selecting a team/athlete that will:

- ✓ Win a minimum of 2 country medals.
- ✓ Top 10 finishes by athletes
- √ 3 qualification of medal rounds

- ✓ Should any event specified in this INP be canceled, postponed, rescheduled, or replaced, CTF shall update the nomination procedures indicated in this INP, as applicable, as soon as reasonably possible and shall communicate any modifications to all impacted individuals, as well as publish the modified INP on its website, prior to the postponed, rescheduled or replacement event.
- ✓ Decisions made pursuant to this clause shall not be subject to appeal and do not apply to the cancellation of events that are conducted under the authority of organizations other than CTF.

1.3 Eligibility Requirements

- ✓ Must be a Canadian Citizen as per Canadian Tenpin Federation Regulations
- ✓ Must be a current Registered member of Canadian Tenpin Federation

- ✓ Must have a valid passport by January 1, 2022 that does not expire before January 23, 2023.
- ✓ Must sign, submit, and comply with COC Athlete Agreement and Eligibility Forms
- ✓ Must sign, submit, and comply with the Canadian Tenpin Athlete Agreement and all Eligibility Forms.
- ✓ The athlete must not be under suspension or any other sanction by any recognized body for doping or doping related offence.
- ✓ Must be following all relevant Pan Am Bowling or World Bowling requirements.
- ✓ Must have competed in Canadian Team Trials in one of the years 2018, 2019, 2022.
- ✓ Performance readiness with no injuries.

1.4 Athlete Nomination

The selection committee will be selecting two male and two female. Only in the case of canceled, postponed, etc will the selection committee be selecting two male and two female. In making selection decisions the Selection Committee will have a degree of discretion and flexibility. The factors considered are listed below. Selection will be made using a combination of objective measures (#1 Category) along with a series of subjective measures (#2 category). The selection committee is free to assign different weightings to the importance of factors considered in their decision-making process as they deem appropriate to the goal of achieving the performance objectives for the 2022 World Games.

#1 Category

- Athlete who medals in World Bowling Competition
- Top 10 finish in World Bowling Competition
- Athlete who medals in Pan Am Bowling Championship
- Top 3 finish at Pan Am Bowling Competition
- Medals at previous World Games

#2 Category

- Practice Regimen
- Lane pattern Versatility and Reporting
- Deadline Commitments set by High Performance Committee
- All Commitments as required by the High Performance Committee
- Sportsmanship demonstrated.
- High Potential Youth Athlete

The Pan Am Bowling criteria can be found at www.panamsports.org, in the event of a discrepancy, the Pan Am Bowling version will prevail the event changes by Pan Am Bowling to the selection and eligibility criteria. The Canadian Tenpin Federation is bound by these changes and will inform the membership as soon as possible,

1.5 Coach Nomination

Selected based on the following objective and subjective criteria.

- NCCP Trained
- Lane Pattern Knowledge
- Tactical knowledge
- Communication
- Leadership Demonstrated
- Deadline Commitments set by High Performance Committee
- Experience at World Bowling and Pan Am Bowling Events
- High Potential Assistant Coach

All coaches must be in good standing with the Professional Coaching Program of the Coaching Association in Canada

1.6 Removal or Replacement

Alternates will be named in both Men's and Women's Divisions. Alternates will comply with all eligibility requirements (see section 1.3)

The circumstances under which an athlete can be removed from a team include doping control infraction, violation of an Athlete Code of Conduct, missed deadlines, workouts, and injury.

As outlined below:

The High-Performance Selection Committee with consultation from coaching staff will be responsible for the nomination of all athletes and Removal/Replacement (if necessary).

An athlete will be removed, and Alternates will be used if there is an injury that precludes the athlete from competing if the athlete fails to meet the standards set forth by Pan Am Bowling, COC or CTF.

1.7 Appeals

The due process for athletes will follow Canadian Olympic Committee guidelines and procedures. In matters involving CTF Members' representation of Canada in National or International competition, including qualifiers for those competitions, CTF due process can be sent to Sport Dispute Resolution Centre of Canada (SDRCC) within 30 days of nominations. http://www.crdsc-sdrcc.ca/eng/file-anappeal

1.8 Team Leader

The Team Leader will satisfy the needs of COC to have team ready for competition with all deadlines met.

At World Games the Coach will take over all Team Leader responsibilities if Team Leader cannot be present.

1.9 Nomination Committee

The Canadian Tenpin Federation Selection Committee will consist of the High-Performance Director, Executive Director-CTF, and a member appointed by the HP Director. If a committee member is absent, retires and committee is short a member the current President of the Canadian Tenpin Federation will take their place until an alternate can be selected. Head Coach or "A" Coaches will submit pre-selections. All CTF nominations are subject to approval by the COC.
